ORDER

Pursuant to notification read (1) above , Principal of KMCT College of Nursing, Kozhikode vide paper read (2) above had submitted application for the enhancement of B.Sc. Nursing seats from 50 to 100 for the academic year 2021-22. However college had not submitted NOC from government.

- 2. Later, college submitted NOC from government for 75 seats of B.Sc Nursing course and requested to consider their application for seat enhancement from 50 to 75 during the academic year 2021-22.
- 3. Subsequently, University conducted inspection in the college and based on the inspection report and compliance report vide paper read (3) above, granted provisional affiliation for the enhancement of B.Sc. Nursing seats from 50 to 70 (at par with the approval of KNMC) during the academic year 2021-22.
- 4. Now , the college vide paper read (4) above has requested to grant seat enahancement from 70 to 90 seats for the academic year 2023-24 considering their previous application for 2021-22 . The college vide paper read (5) & (6) above, has also submitted NOC from Govt and KNMC sanction for 90 seats.
- 5. As per clause 2(5)(ii)(v) of affiliation statute "In the case of additional courses and/or for enhancement of seats, the colleges shall satisfy the condition that 1st batch of the courses in the institution under the same stream shall be passed out and the details of the average of pass percentage of previous regular examinations of all existing batches of the same course at the time of submitting the application and a declaration that the percentage is not below the minimum prescribed by the Governing Council in the Notification issued by the University for the purpose of the addition/enhancement concerned."

- 6. As per U.O. No. 69/2022/academic/KUHS Dated 07/02/2022 the above clause of affiliation statute has been modified as follows "If seat enhancement is already permitted in an existing course and the applications for further enhancement of seats, the batch in which enhancement was last sanctioned shall be treated as first batch for the purpose of considering further enhancement of seats."
- 7. On the basis of the above norms, University vide paper read (7) above, had rejected the request submitted by the college for the enhancement of B.Sc. Nursing seats from 70 to 90 for the academic year 2023-24 and requested to submit fresh online application in subsequent academic years after enhanced batch passed out from the institution.
- 8. Aggrieved by this, the college filed WPC No.34522/2023 before the Hon'ble High Court seeking direction to the university to grant provisional affiliation to the enhanced intake of B.Sc Nursing seats from 70 to 90 in this academic vear itself.
- 9. The Hon'ble High court vide paper read (8) has disposed the WPC No.34522/2023 with a direction to this University (4th Respondent) to consider the application for affiliation of the enhanced intake of B.Sc. Nursing seats from 70 to 90 in this academic year itself and pass necessary orders on or before 23.11.2023 after following the procedure prescribed.
- 10. Accordingly, university conducted inspection on 15/11/2023 at the college and after examining the inspection report and compliance report the scrutiny committee vide paper read (9) above, recommended to grant Provisional affiliation for the enhancement of B.Sc Nursing seats from 70 to 90 for the academic year 2023-24.
- 11. Subsequently this matter was placed before the Sub Committee of the Governing council for provisional affiliation and vide paper read (10) above has also recommended to grant provisional affiliation to KMCT College of Nursing, Kozhikode for the enhancement of B.Sc Nursing seats from 70 to 90 for the academic year 2023-24 subject to the suitability from Indian Nursing council and subject to the condition that if intake is reduced either by KNMC and INC the number of seats to which admission can be made should be reduced accordingly.
- 12. The Principal of KMCT College of Nursing Kozhikode vide e-Challan No. KUHSREFDST9931300610948 dated 24/11/2023 has remitted Rs. 2,20,600/- (Rupees Two lakh Twenty thousand and Six hundred only) for Interest free Refundable deposit for enhancement of seats and vide e-Challan No. KUHSFPAS4302000610941 dated 24/11/2023 has remitted Rs.1, 10,400/- (Rupees One lakh Ten Thousand and Four hundred only) towards provisional affiliation fee.

In this circumstances, sanction is hereby accorded to grant Provisional Affiliation to KMCT College of Nursing, Kozhikode for the enhancement of seats of B.Sc. Nursing Course from 70 to 90 for the academic year 2023 24 subject to the ratification by the Governing Council and subject to the suitability of Indian Nursing Council and subject to the condition that if intake is reduced either by KNMC and INC the number of seats to which admission can be made should be reduced accordingly.

The Judgement dated 08/11/2023 of the Hon'ble High Court in WP (C) No.34522 / 2023 filed by the Principal, KMCT College of Nursing, Kozhikode is thus complied with.

The college shall strictly adhere to the general conditions detailed below:-

- i. The College shall submit Suitability from INC to the enhanced seats for the academic year 2023-24.
- ii. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- iii. In the light of the direction of the Supreme Court of India in Writ Petition (c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- iv. Affiliation granted is strictly provisional and only for the academic year 2023-24. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.


ORDER

Vide paper read (1) above, University had invited application for provisional affiliation of new courses from affiliated nursing colleges for the academic year 2021-22. Accordingly, Principal KMCT College of Nursing, Kozhikode vide paper (2) above, submitted applications for provisional affiliation for starting following M.Sc Nursing Courses with seats mentioned against each for the academic year 2021-22

- 2. University processed the application . At the time of submitting application the college had not obtained the NOC from Govt for M.Sc specilaities. Later, the college had submitted the NOC from Govt for three M.Sc specilaities (M.Sc Medical Surgical Nursing-3 seats, M.Sc Community Health Nursing-3 seats and M.Sc Paediatric Nursing-3 seats) with 3 seats each for the year 2021-22 .But, there was not enough time to complete the process for granting provisional affiliation to start the above said courses during the academic year 2021-22. Subsequently, college was directed to submit a request to reconsider their application within the validity period of the application.
- 3. Vide paper (3) above, college requested the university to re consider their application for starting M.Sc Medical Surgical Nursing (Cardio Thoracic Specialty) with 2 seats and M.Sc Community Health Nursing with 3 seats for the academic year 2023-24.
- 4. Vide paper read (4) and (5) above, the college has submitted recognition from Kerala Nurses and Midwives Council & No Objection Certificate from Govt respectively for the proposed seats for the academic year 2023-24.
- 5. The scrutiny committee, on verifying the report of the inspection conducted in the college in connection with granting of provisional affiliation for starting Post Basic B.Sc Nursing programme for the academic year 2022-23 vide paper read (6) above, has also recommended to grant provisional affiliation to this college for starting M.Sc Community Health Nursing with 3 seats for the academic year 2022-23.
- 6. After that, University had inspection in the college to assess the suitability for granting provisional affiliation for Medical surgical Nursing (Cardio Thoracic Specialty) for the year 2023-24. Up on verification of the inspection report read (7) above, the scrutiny committee, vide paper read (8) above, has recommended to grant Provisional Affiliation to start M.Sc. Medical Surgical Nursing (Cardio Thoracic specialty) with an annual intake of 02 students for the academic year 2023-24 .The committee also recommended to grant Provisional Affiliation to start M.Sc. Community Health Nursing with an annual intake of 03 students for the academic year 2023-24 .
- 7. The recommendation of the scrutiny committee was placed before the sub committee of Governing council held on 01/08/2023 and sub committee vide paper read (9) above, recommended to grant provisional affiliation to start M.Sc Medical Surgical Nursing with 2 seats and M,.Sc Community Health Nursing with 3 seats for the academic year 2023-24, subject to the suitability of Indian Nursing Council.
- 8. The Principal of KMCT College of Nursing vide e challan No.KUHSREFDPG3921727410919 dated 23/08/2023 and e-challan No. KUHSREFDPG3261727110923 dated 19/08/2023 remitted fee of Rs. 3,30,800/- for each course (Rupees Three lakh Thirty Thousand and Eight hundred only) towards interest fee Refundable Deposit and Vide e-challan No.KUHSFPAPG2841627110915 dated 19/08/2023 and E-challan No.KUHSFPAPG6301627410995 dated 22/08/2023 has remitted fee of Rs. 1,10,300/ (One Lakh Ten Thousand and Three Hundred only) for each course towards provisional affiliation fee (payable at the time of affiliation)
- 9. In this circumstances, considering the urgency of allotment process to nursing programmes ,sanction is hereby accorded to grant Provisional Affiliation to KMCT College of Nursing, Kozhikode for starting M.Sc Medical Surgical Nursing with 2 seats and M.Sc Community Health Nursing with 3 seats for the academic year 2023-24 ,subject to ratification by the Governing Council and subject to the suitability from Indian Nursing Council
- 10. The college shall strictly adhere to the general conditions detailed below:-
- i.Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

- 2. University conducted inspection in these colleges in order to verify the facilities for the conduct of the course .Upon verification of the inspection reports , scrutiny committee has pointed out certain deficiencies and which were intimated to the colleges.
- 3. Subsequently, on verification of the complaince reports of colleges, scrutiny committee recommended to grant continuation of affiliation to above nursing colleges for conducting the courses with intakes mentioned against each during the academic year 2023- 24.



- 4.The above colleges have submitted approval of KNMC for the academic year 2023-24 and constituted college council as stipulated in the Amendment of the First Statute on the matter of affiliation of colleges and submitted MoU from affiliated hospitals as per MSR of KUHS. However colleges have not obtained the suitability from Indian Nursing Council for the academic year 2023-24.
- 5. In this circumstances, considering that admission process to nursing courses is going to be started soon, and based on the recommendation of scrutiny committee, sanction is hereby accorded to grant continuation of affiliation to the the above nursing colleges to conduct courses with intake mentioned against each during the academic year 2023-24 subject to ratification by the governing council and in anticipation of approval from Indian Nursing Council and; subject to the condition that If the intake is reduced either by KNMC or INC, the number of seats to which admission can be made should be reduced accordingly.


